

DANCE BURSARY APPLICATION FORM

Arts Umbrella's bursary fund is made possible due to the generous support of corporations, foundations, and individuals in the community. Partial bursaries are available for students with an aptitude for serious training and who have financial need. All such requests are evaluated on the basis of demonstrated family means. In keeping with Arts Umbrella's mandate, every effort is made to ensure no Canadian student is deprived access because of financial circumstances. Limited assistance may also be extended to non-Canadian students based on financial need and the availability of funds. In the interest of allocating as fairly as possible and to ensure that those genuinely in financial need receive assistance, we ask that you and/or parents/guardians exercise accuracy and honesty in filling out this form. As limited funds are available, application does not guarantee assistance. Awards exceeding \$500 per year will be issued a T4A in compliance with Revenue Canada requirements.

- Proof of income for both spouses and/or partners (most recent Tax Summary, or official documentation from the applicable department of government assistance)
- A letter describing circumstances that would make it difficult for you to finance your Arts Umbrella tuition.

Terms and Conditions

NEW: 50% of tuition is due June 30. (Tuition includes a \$100 non-refundable deposit). Remaining balance of tuition may be paid in 2 installments due November 15 and February 15 if arranged.

Costs are payable in full at time of registration. ie. school uniforms, costumes, transportation, books, lockers, photo sitting fees, videos, tickets etc .

As a not for profit visual and performing arts institution Arts Umbrella charges tuition fees which cover only a portion of the real costs. Tuition rates are based on full program requirements and will not be prorated for students wishing to take less than the full program. Financial assistance is available through our bursary program.

A late registration fee of \$100 will apply after June 30

Withdrawal and Refund Policy

If a request for withdrawal is received 2 weeks before the program commences, Arts Umbrella will refund the balance less \$100 deposit.

If a request for withdrawal is received 2 weeks before the program commences and before September 30, Arts Umbrella will retain 30% of the tuition fees.

If a request for withdrawal is received after October 1 and before December 1, Arts Umbrella will retain 50% of the tuition fees.

No refund will be issued after December 1 except in the case of illness or injury, where a pro-rated refund may be issued if a written request for withdrawal is accompanied by a physician's note.

All requests for withdrawal must be forwarded in writing to the attention of the Registrar. Arts Umbrella will pay any eligible refund within thirty (30) days of the Registrar receiving a written notice of withdrawal. Non-attendance or non-payment of outstanding fees does not imply a formal withdrawal.
